5. Treasury Report

Martha Bergweiler discussed our current balance, \$16,582.46.

Martha asked the bank if we could get a gift card to use as payment for future Amazon purchases. They do not do that anymore so we would need a credit card or debit card. The credit card had an annual fee but the debit card has no fees so Martha chose that. Now we have a debit card to use for these types of purchases and avoid the need for reimbursements.

The Amazon gift card was for March drawing. Jen Mosier said the recipient for April's drawing has yet to respond.

Meghann explained our SPAC underwriting contribution was unnecessary due to high attendance, and therefore refunded as part of our SPAC proceeds.



Meghann asked the Board to brainstorm ways to spend more money on members.

6. Publicity

Jen Mosier presented. Great YouTube response (70 views on Sunny video, 100 on FL Tenure video). Twitter has over 100 followers now (nearly double since December 2016). We carry more followers than most chapters our size.

Still plugging at social media sites including Google+ which is new. We have updated our website with Sunny photos and a travel log.

We started a monthly newsletter. We can highlight the June meeting in the next newsletter. SPAC and Conference will also be in the next newsletter. If anyone has content ideas, email ideas to Jen Mosier.

7. Promotions

Ruth Turman presented. Ruth sent everyone a 2-pager read-ahead with updates for promotions. We are ahead of where we were last year prior to Bid & Proposal Con, we submitted nominations for 3 chapter awards. We nominated 2 members for "40 under 40" award.

Last count, 4 board members would be at Bid & Proposal Con.

We have 1,000 anniversary balloons to hand out. Ruth also has balloon sticks so we won't need helium.

Instead of an anniversary cake, Ruth will put a birthday card out at registration that people can sign.

Ruth wants to get a group photo at the industry dinner, we can ask the APMP Photographer to take the photo.

Sunny's passport is ready for New Orleans along with mini Sunnys.

Ruth wants to create a chapter banner listing number of certifications, awards, and things that can be added over the years to take to APMP conferences.

For 2017, we should start promoting nominations for our Annual Honors Program now and continue to do so now and up until the end of October, which is the deadline. Jen Mosier suggested we add that to newsletter moving forward.



We want Sunny to be passed among members with direct contact to help increase contact between members. We have members in South America so it would be great to get him down there.

Ruth would like to see us bump up support of certification program but it would be great to have a higher percentage of certified membership. We did a chapter survey two years ago; it might be a good idea to reach out to the members again this year to see how we can support them.

Team decided we should survey members every year. We can address feedback through the newsletter. Everyone should email question ideas for the survey.

Alyssa confirmed her registration for Bid & Proposal Con and volunteered to help Ruth with the balloons and whatever else she found to replace sunshine balloon that Alyssa used to carry around.
